Your privacy is very important to us. Please read this privacy policy to learn more about the ways in which we use and protect your posted information.

#### **What This Privacy Policy Covers**

- This policy covers how MasterNegotiator treats posted information that MasterNegotiator collects and receives, including information related to your past use of MasterNegotiator products and services. Posted information is information that is posted to this site like your name, address, email address, or phone number, product specifications and other information that may not otherwise be publicly available.
- This policy does not apply to the practices of companies that MasterNegotiator does not own or control or to people that MasterNegotiator does not employ or manage.

#### **Information Collection and Use**

MasterNegotiator.com collects posted information when you request information from the site, when you use MasterNegotiator.com's products or services, when you visit MasterNegotiator.com pages or the pages of certain MasterNegotiator.com partners. MasterNegotiator.com may combine information about you with information we obtain from business partners or other companies.

- When you request information on a particular deal, we may ask for information such as your name, email address, zip code and other information. Once you request information from MasterNegotiator about the site's deals or services, you are not anonymous to us.
- MasterNegotiator may collect information about your transactions with the site and/or its partners, advertisers, or affiliates.
- MasterNegotiator automatically receives and records information on our server logs from your browser, including your IP address, MasterNegotiator cookie information, and the page(s) you request.
- MasterNegotiator uses information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, to generate revenue and provide anonymous reporting for internal and external clients.
- MasterNegotiator does not rent, sell, or share posted information about you with other people or nonaffiliated companies except to provide products or services, or under the following circumstances:
- We provide the information to trusted partners who work on behalf of or with MasterNegotiator under confidentiality agreements. These companies may use your posted information to help MasterNegotiator communicate with you about offers from MasterNegotiator and our marketing partners. However, these companies do not have any independent right to share this information.
- We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims;
- We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of MasterNegotiator's terms of use, or as otherwise required by law.

- We transfer information about you if MasterNegotiator is acquired by or merged with another company.
- MasterNegotiator may display targeted advertisements based on posted information.
- MasterNegotiator works with vendors, partners, advertisers, and other service providers in different industries and categories of business.
- MasterNegotiator may set and access MasterNegotiator cookies on your computer.
- MasterNegotiator may let other companies that show advertisements on some of our pages set and access their cookies on your computer. Other companies' use of their cookies is subject to their own privacy policies, not this one. Advertisers or other companies do not have access to MasterNegotiator's cookies.

### **Editing and Deleting Your Account Information**

- We reserve the right to send you certain communications relating to the MasterNegotiator service, such as service announcements, administrative messages and the MasterNegotiator Newsletter, that are considered part of your MasterNegotiator account, without offering you the opportunity to opt-out of receiving them. However, email communications will have an opt-out ability clearly identified in every communication.
- You can have your MasterNegotiator account deleted by sending an email to our webmaster. Once your account is deleted, there still may be information that remains in our archived records and backups after your account has been deleted.

### **Confidentiality and Security**

- We limit access to posted information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.
- We have physical, electronic, and procedural safeguards to protect posted information about you.
- We can not guarantee however, that someone will not exploit this service, mitigate our security or gain access to your data that may not otherwise be available.
